Mr. Baldrige is currently chair of Baker Donelson's Intellectual Property Group and concentrates his practice in intellectual property and technology litigation. He frequently provides training for his clients and their employees on how to properly handle trade secrets of the company. Mr. Baldrige frequently advises clients regarding non-disclosure and confidentiality obligations and agreements, helping his clients protect intangible assets as well as developing creative solutions for clients on how to avoid breaching non-disclosure obligations.
