- Foldable end-frame cleated container for storage and shipping of heavy durable goods, with reduced labor and packaging costs
- Rackable wrought iron fence panels that follow contour of ground rather than requiring rectangle fence panel installed in stair-step fashion
- Hard cover book binding with concealed security device for inventory tracking and control
- Retaining wall structures with tensile reinforcement-to-retaining wall mechanical connection
- Acoustical wall covering assembly that is pleated and installed in place for covering walls of movie theatres
