- Successfully defended an OB-GYN in a medical malpractice case alleging negligent failure to do a pregnancy test before myomectomy surgery, resulting in a voluntary non-suit during trial.
- Obtained a jury verdict in favor of an internal medicine physician in a case alleging negligence in prescribing Indocin to a patient with chronic renal failure, causing acute failure and the need for dialysis.
- Obtained a jury verdict in favor of a general surgeon in a case alleging lack of informed consent in the performance of a thyroidectomy, resulting in permanent hoarseness.
- Defended a physician against allegations of sexual abuse, resulting in a mistrial due to the plaintiff's counsel's misconduct during trial.
- Successfully defended a physician in a case alleging he negligently performed abortion, resulting in a voluntary non-suit during trial.
