She also regularly represents financial institutions in litigation related to claims of alleged breach of fiduciary duty, alleged statutory violations, alleged wire fraud, and alleged collection issues.

Ms. Henderson also has significant experience with insurance defense litigation, including first-party residential and commercial property claims, third-party claims, and flood-insurance claims throughout Texas. She has defended numerous cases involving allegations of breach of contract, bad faith, insurance code violations, and coverage issues.

Representative Matters

- Successfully defended financial institutions in arbitration against allegations of harassment, invasion
 of privacy, and Texas Debt Collection Act violations. Successfully defeated a later appeal by the
 claimant before the Court of Appeals for the Fifth District of Texas at Dallas in which the claimant
 challenged the arbitrability of the matter.
- Defended financial institutions in actions throughout Texas regarding alleged wire fraud, breach of fiduciary duty, and the implications and effects of the Bank Secrecy Act and other privacy laws.
- Represented financial institutions in collections matters throughout Texas involving amounts ranging between \$1,500 to more than \$15 million.
- Obtained final summary judgment in favor of a mortgage servicer and owner of a mortgage loan
 against allegations of wrongful foreclosure, violation of the Texas Debt Collection Act, and a request
 for a declaratory judgment that the note and deed of trust were void. Successfully handled a later
 appeal of the final judgment before the Court of Appeals for the Fifth District of Texas at Dallas.
- Successfully prosecuted a quiet title action on behalf of a mortgage lien holder against a third-party buyer of the property who fraudulently transferred title to avoid complying with Texas requirements related to home-owners association foreclosure sales.
- Obtained final summary judgment in favor of an insurance company and dismissal of all of the
 insured's claims for alleged breach of the policy and violations of the Texas Insurance Code in the
 Southern District of Texas-McAllen Division due to the insured's failure to provide prompt notice of his
 claim and the prejudice the insurance company suffered as a result in a case alleging property
 damage caused by a hail storm.
- Won summary judgment on behalf of an insurance broker in a lawsuit in Texas federal district court arising from the denial of insurance coverage for a loss due to wire fraud.
- Won a motion for summary judgment on behalf of a loan servicer in a contested foreclosure lawsuit. Following the borrower's appeal, the appellate court affirmed the judgment.
